(NOTE by A.M. Isdale. As indicated by a note on p. 132, reading on August 1, 1867, Proclamation on July 31 is incorrect.

On 27 July, 1869, James Mackay himself made a long report on the Thames Goldfields, from his Civil Commissioner's Office in Auckland. This sums things up.

"On the 30th July, 1867, the Hon. Dr. Pollen issued a Proclamation, constituting the lands mentioned in the agreement to be a gold field, and declaring the same open for gold-mining on and after the 1st August, 1867.

"I received instructions from the Hon. Dr. Pollen to proceed to Kauaeranga (as it was then first named) Shortland, and take temporary charge of the goldfield ... I left Auckland on the 1st August in the paddle-steamer "enterprise No. 2."

Therefore the re-enactment of the reading of the proclamation on August 1, 196 , at the Thames Goldfield by James Mackay, was correct as to date.)
